1 particularly significant, the State Lands Commission could
2 be receiving a number of similar requests over the next
3 several years. As you know, several oil companies,
4 including Getty, Exxon, Aminoil and ARCO are preparing
5 plans for onshore oil bases and tanker loading terminals
6 off Santa Barbara's coast, at Gaviota, Las Flores Canyon,
7 Elwood, and possibly at Vandenberg Air Force Base.

8 It is the stated policy of the County of Santa
9 Barbara that these individually planned facilities be
10 consolidated into one facility for use by all companies
11 to avoid a proliferation of industrial sites along the
12 coast. Such a policy is also clearly in the best interests
13 of the public. Furthermore, extensive studies are now being
14 done by the County Petroleum Transportation Company, PTC,
15 to determine whether, or to what extent, the use of tankers
16 to transport oil is appropriate.

17 I would, therefore, urge the State Lands
18 Commission to add a termination clause to the Aminoil lease
19 which would give the Commission the authority to terminate
20 with notice this Aminoil marine terminal lease at such
21 time as a single marine terminal, if any, for use by all
22 oil companies becomes operational. I would furthermore
23 urge that the State Lands Commission not approve any
24 additional leases for any new marine terminals or piers
25 related to supply-based functions until a decision has

1 been reached as to where the primary facility is to be
2 located.

3 Thank you.

4 CHAIRPERSON CORY: Questions from Commissioners.

5 COMMISSIONER McCARTHY: I have a couple, Mr.
6 Chairman.

7 As I understand these items before us, they are
8 existing leases and the lessees are trying to exercise
9 their option to renew the lease under this legal instrument.

10 Are there two existing marine terminals servicing
11 these two lessees? Is this one terminal?

12 MR. TROUT: Mr. McCarthy, on item C10, the
13 approval of the five-year lease, that is just for mooring
14 a crew boat which is attendant to the existing pier and
15 it's just used to, the boats are used to ferry people out
16 to the existing platforms. It is not an existing lease,
17 however. It is a new lease for a small mooring buoy. It's
18 not for a tanker anyway.

19 CHAIRPERSON CORY: But the newness is that portion
20 for the buoy --

21 EXECUTIVE OFFICER DEDRICK: That's correct.

22 CHAIRPERSON CORY: -- not for the oil extraction
23 or the pier.

24 MR. TROUT: Right.

25 CHAIRPERSON CORY: Currently they have been tying

1 the vessel either out at the platform or at the pier and
2 they would like to remove it from the side of the pier
3 and have it on a buoy next to the pier, and that is the
4 net change of CIO.

5 MR. TROUT: Yes. They're just adding one more
6 buoy. I think there are two buoys there now.

7 CHAIRPERSON CORY: But the new lease that you
8 use in your language is not a new oil lease, it's a new
9 buoy lease?

10 MR. TROUT: Correct, Mr. Chairman.

11 COMMISSIONER McCARTHY: Do they have authority,
12 does Exxon have the legal right under any of the conditions
13 of the lease we are being asked to review to construct
14 any other kinds of facilities?

15 MR. TROUT: No, sir. Only mooring buoy.

16 COMMISSIONER McCARTHY: I listened to Assemblyman
17 O'Connell's request which I would like to respect, and
18 I'm trying to understand how the Exxon request before us
19 which you just heard described is in conflict with his
20 desirable approach to try to consolidate the marine terminal.

21 MS. WETTERER: I think he's concerned about the
22 effect of several over the years such requests are made.
23 He would like them all to be consolidated into one.

24 COMMISSIONER McCARTHY: This lease renewal is
25 not for construction of any facility. It's to give them

1 permission to attach their boats to the buoy instead of
2 alongside the existing pier. So we're not talking about
3 any new construction. I'm sympathetic to the point made
4 about there ought to be some sort of consolidation of
5 terminals for whatever offshore drilling proceeds in the
6 next few years. Now, this renewal is not in conflict with
7 Assemblyman O'Connell's expressed desire. Do you get the
8 point I'm --

9 MS. WETTERER: I see what you're trying to say,
10 but I think they're just, as you know, the situation in
11 Santa Barbara, they're just concerned about anything that's
12 done.

13 COMMISSIONER McCARTHY: Nor is Exxon authorized
14 to proceed under renewal of this lease with the construction
15 of any facility.

16 MS. WETTERER: Well, I think they're also talking
17 about the second one as well.

18 COMMISSIONER McCARTHY: We'll get to the second
19 one in a minute, but I just wanted to --

20 MS. WETTERER: This addresses I think both of
21 the situations.

22 COMMISSIONER McCARTHY: -- have Assemblyman
23 O'Connell understand that this one was first, the renewal
24 of this lease which frankly we're obliged to do anyway
25 since they have the legal right to exercise the renewal

option. But even so, it's not in conflict with Assemblyman O'Connell's expressed desire and I guess the County's expressed desire. All right.

MS. WETTERER: Okay.

COMMISSIONER McCARTHY: Thank you, Mr. Chairman.

CHAIRPERSON CORY: Essentially I tend to concur with at least from the testimony of the Assemblyman's concern, that I am prepared to vote to approve the Exxon buoy and I think that is consistent with the Assemblyman's wishes given the legal ramification, if there is no objection.

COMMISSIONER McCARTHY: I don't have any objection, Mr. Chairman.

I might ask a point for my own information. Does our staff know whether Exxon is specifically proposing construction of terminal facilities along the Santa Barbara coast?

EXECUTIVE OFFICER DEDRICK: Yes, Mr. Chairman. I'm sorry, Mr. McCarthy.

There is a proposal before Santa Barbara County and the local governments to construct a terminal at the mouth of Las Flores Canyon. Exxon has a lease from the State Lands Commission for that area. The lease would not allow construction of that terminal until the terminal itself is planned, presented to the Commission, and the Commission has the discretion to approve or disapprove

that terminal.

COMMISSIONER McCARTHY: Mr. Chairman, I don't know what point we are at in trying to accede to the kind of request being advanced by Assemblyman O'Connell here. I don't even know if the issue is ripe yet. Are we at the point where there's been any discussion between our staff and the Santa Barbara County staff and oil company representatives about trying to consolidate whatever facilities are built?

EXECUTIVE OFFICER DEDRICK: Yes. We've had extensive discussion. We've been working with Santa Barbara County and the other local and state agencies for over a year and a half. The State Lands Commission has a member on that pipeline study committee that Donna was talking about and it is true that there are proposals coming to us which have not come to us yet for a total of three offshore terminals and a couple of onshore facilities that will require pipelines.

CHAIRPERSON CORY: So we're there but it's not yet at the point where an application is before us?

EXECUTIVE OFFICER DEDRICK: That's correct. The companies all understand that their best course of action is to have all those dealt with simultaneously so that prudent decisions can be made by local governments and by this Commission.

COMMISSIONER McCARTHY: Thank you.

1 CHAIRPERSON CORY: Without objection then, item
2 C10 will be approved which is the buoy adjacent to Elwood
3 for Exxon.

4 The second item is 19, the Aminoil request which
5 is the termination of the 15-year lease and the approval
6 of a 10-year new lease, and this is a renewal?

7 EXECUTIVE OFFICER DEDRICK: That is correct.

8 Mr. Taylor, did you want to address this?

9 MR. TAYLOR: This in essence is Aminoil's exercising
10 of a right of renewal for ten years. If you notice on
11 page 110, it talks about the terms of the original lease.
12 It was 15 years from February the 29th, 1968, and the renewal
13 options were three successive periods of ten years each.
14 The Commission is entitled -- it must renew it on reasonable
15 terms and conditions. The reasonable terms and conditions
16 here are a substantial increase in rent, our renewal of
17 their agreement to abide by all the tanker safety
18 regulations which this Commission developed several years
19 ago, and a number of other housekeeping items as well as
20 using a new lease form which is a cleaner object.

21 If Aminoil had not agreed to that and insisted upon
22 its right of renewal, the same old lease would have been
23 used with a whole bunch of paragraphs just tacked on. It
24 wouldn't have been as clear to understand or to read.
25 So it was decided by both parties that the way to handle

1 the renewal was just to rewrite the lease.

2 You are not extending the rights under the original
3 lease. You are staying right with those. This proposed
4 lease will go for ten years and have two successive periods
5 of ten years. And if you add those together, that matches
6 the 30 years of renewal rights that are on the terms of
7 the original lease which both of these are seen on pages
8 110 and 111 of your calendar.

9 CHAIRPERSON CORY: So what you're telling us
10 is that we don't have a legal option to impose a standard
11 the Assemblyman would like us to do, that we are locked
12 into, in essence, 45 years of use of this specific property
13 for this purpose from 1968 and the only question is the
14 amount of money, that we really are obligated to renew?

15 MR. TAYLOR: That is correct. And also we have,
16 the staff has incorporated additional provisions in the
17 lease which bring it up to modern standards.

18 EXECUTIVE OFFICER DEDRICK: If Aminoil is --
19 oh, excuse me. I'm sorry.

20 COMMISSIONER McCARTHY: Mr. Chairman, if I may,
21 first question. I have looked at the rent out here, \$278.30.
22 How was that established?

23 MR. TAYLOR: That was the old rent.

24 COMMISSIONER McCARTHY: What is the new rent?

25 MR. TAYLOR: The new rent is --

1 MR. HIGHT: The new rent now is \$47,043.

2 COMMISSIONER McCARTHY: Annually?

3 MR. HIGHT: Yes.

4 COMMISSIONER McCARTHY: How is that established?

5 Briefly.

6 MR. TROUT: Lance Kiley, our Division Chief,
7 and Gary Horn can answer detailed questions. It's based
8 on an appraised value of the land which establishes a minimum
9 plus a throughput or a credit against that minimum on a
10 per-barrel transfer and then an additional rate beyond
11 that. So that's current market value. It's consistent
12 with leases that the Commission has issued recently to
13 other oil companies.

14 COMMISSIONER McCARTHY: This is an existing marine
15 terminal with submarine loading pipeline. This is already
16 built.

17 EXECUTIVE OFFICER DEDRICK: Yes.

18 COMMISSIONER McCARTHY: Is there any new
19 construction being proposed here?

20 MR. TROUT: Not in this lease. Aminoil is
21 considering a revision of their marine terminal, but there
22 is nothing in this lease which would allow them to expand
23 it or otherwise make additional use of it other than that which
24 has been authorized in the past.

1 it, what would they have to do?

2 MR. TROUT: They would have to apply to the Lands
3 Commission and to the County and other local governmental
4 agencies. There would have to be an EIR. And that's one
5 of the three that the Executive Officer mentioned, one
6 of the three proposals that should be tied together.

7 COMMISSIONER McCARTHY: What power do we have
8 to persuade, cajole Aminoil to somehow cooperate with other
9 oil corporations?

10 CHAIRPERSON CORY: We don't have to grant any
11 new leases. So when they come in with theirs we say:
12 No, we don't like it. That's fairly effective, I think

13 COMMISSIONER McCARTHY: New leases, not this
14 facility?

15 CHAIRPERSON CORY: They can't expand this one.
16 We're already hung out to dry. But if they want to expand
17 it, they will have to do their EIR. When they come in
18 we can look at the whole thing and we can come to a
19 conclusion that the State of California and all the
20 considerations are better served by combining into one
21 as the Assemblyman suggests based upon the evidence of
22 that EIR and the hearing that we have before us.

23 COMMISSIONER PIERCE: But they continue to
24 operate independently until such time.

2 regardless if they choose not to buy into a consolidated
3 terminal.

4 CHAIRPERSON CORY: But they cannot expand their
5 operation beyond what they have a lease right for now.

6 COMMISSIONER PIERCE: Which is an additional
7 30 years?

8 CHAIRPERSON CORY: Do they still have another
9 30 years to go on that lease? That we can't take away
10 from them because of their contractual rights. That's,
11 I guess, the distinction that may get lost in the press
12 of the community, but that's where we're at.

13 MS. WETTERER: I understand.

14 COMMISSIONER McCARTHY: Our own counsel and the
15 Attorney General's Office are advising us that --

16 MR. TAYLOR: That's correct.

17 COMMISSIONER McCARTHY: -- there's no question
18 that Aminoil has a right to renew for ten years successively
19 for three periods of time, this being the beginning of
20 the first.

21 MR. TAYLOR: That's correct.

23 as to their right at this time to pursue that renewal of
24 the lease.

2 MR. TAYLOR: They have lived up to all the terms
3 and are in good standing at this point and they're exercising
4 their rights.

5 I think that you can see that the staff has
6 negotiated substantial improvements in this lease over
7 the earlier one. They feel that they pushed as far as
8 we can successfully under the reasonable provisions.

9 Mr. McCarthy, you asked for a copy of the original
10 lease and to be shown the paragraph. It's paragraph 20,
11 the term of the original lease. A copy of that original
12 lease is being handed to you and here is a copy of the
13 new proposed lease.

14 COMMISSIONER PIERCE: Mr. Chairman.

15 CHAIRPERSON CORY: Yes.

16 COMMISSIONER PIERCE: A question of the Attorney
17 General's Office. In converting to the new lease, the
18 new lease format and statement, does it in any way enhance
19 the lease agreement on the part of the lessee? Is there
20 added benefit to them and are there the provisions --

22 is that they have more stringent requirements under which
23 they must perform in terms of tanker safety, in terms of
24 some of the other requirements, and certainly in with regard
25 to the amount of money they're going to be paying. That

was particularly, the funding was an item of great concern.
2 It is a tighter lease than the original terms of their
3 operation.

4 CHAIRPERSON CORY: I don't know of any particularly
5 significant benefits they got out of the deal other than
6 the fact of the price of doing business in California.

7 COMMISSIONER PIERCE: Thank you. We appreciate
8 that on our side of the shop.

9 CHAIRPERSON CORY: Okay. Any further questions
10 on this?

11 What is the wish of the Commissioners? Do you
12 wish to go ahead and approve?

1 of terminals and pipelines is one which is going to be
2 one of the hottest issues in the next few years and certainly
3 the Assemblyman has brought it to the attention of the new
4 Commissioners and it's one in which the Commission has
5 been involved. It's a very complicated problem. It's
6 been studied by OPR. It's being studied by the Coastal
7 Commission. It's been studied informally by the ARB.
8 Mary Nichols had a group that was studying the problem,
9 too.

10 I'm not sure exactly what the County's position
11 currently is, but they had signed the Memorandum of
12 Understanding with regard to the Exxon terminal which is
13 not yet existing which the County would have agreed to
14 that. Now, I don't know that there's been a change in
15 that position, but I know from the Coastal Commission's
16 standpoint there's been no hearing on that and that's going
17 to be quite a complicated problem.

18 COMMISSIONER McCARTHY: Mr. Chairman, one
19 concluding point. I know it may be difficult for several
20 oil companies who desire to have their own independent
21 operations and control over their own facilities to try
22 to do this, but I think it's important at this public hearing
23 for myself to indicate that I think Assemblyman O'Connell
24 has a very valid point and I intend to try to do whatever
25 is necessary to bring about a consolidation of those
