MR. HIGHT: Yes. For the record, I would like to state that you will be acting in a nonvoting capacity for the Controller. And Susan Wallace will be acting in a voting capacity for the Lieutenant Governor.

ACTING CHAIRPERSON RASMUSSEN: Thank you very

The next item of business is the report of the Executive Officer.

MS. DEDRICK: No report this morning, Madam Chairman.

ACTING CHAIRPERSON RASMUSSEN: All right. Thank you very much.

The consent agenda is Item C-1 through C-14

I believe. And these are items that have been deemed to be

noncontroversial and rather routine.

I'm Ronald King. I'm the disputed owner of King's Island. And the basic question is where the county line lies. I say it lies to the south of this property, making it part of King's Island. That gives me and my father -- for many years past, since 1939 -- adverse possession of this property.

That's basically my presentation. It's very difficult for me to prove that to you at this time.

There's a lot of situations going on out there that I don't know whether you're aware of or not. But I strongly oppose the issuance of this permit.

ACTING CHAIRPERSON RASMUSSEN: All right. Thank you very much.

MR. KING: I have one further item. There is an ongoing investigation by the Narcotics Division of the Contra Costa County Sheriff concerning these people on that property. I was made aware of that just the other day.

EXECUTIVE OFFICER DEDRIC Item 22 is off calendar, Madam Chairman.

ACTING CHAIRPERSON RASMUSSEN: Thank you. Item 22 is off calendar.

EXECUTIVE OFFICER DEDRICK: Item 23, this is an a request for authorization by the Chevron Company to replace a power cable from Plastform Esther to the shore.

As you recall, Island Esther was washed out in the storms two or three years ago. Chevron has installed a platform to replace it. Initially, they thought that the existing power cable had survived the storm. It did not.

And they are now requesting permission to replace it.

ACTING CHAIRPERSON RASMUSSEN: Any questions on 23? It's moved and approved as presented.

Item 24.

EXECUTIVE OFFICER DEDRICK: Item 24 is a request by the staff for approval to reduce letters of credit on royalty oil sales until the market conditions improve.

It's rather a complex guestion, and I think that we'd be well served if Moose Thompson gave you a report on the status of the whole situation.

MR. THOMPSON: Our main problem is that all of our contracts are tied in to posted price. And posted prices are not coming down as fast as the spot market.

Therefore, a purchaser from us is paying us a bonus above posted price, which is not reflecting the true market price. It's beginning to approach it very close now, but this is the reason why these sell-offs are being turned back to us. Actually, they can pay the bonus to us, go out and buy equivalent oil on the market cheaper than they could pay posted price and bonus to us. And until this market situation clears up, we don't see any need in going out into the market because, again, we have to have a

1 bonus above our posted price. And until the two have some 2 semblance of the real reflection of the market price, there's no point in going out. ACTING CHAIRPERSON RASMUSSEN: Any questions on Item 24? MR. THOMPSON: And therefore, the reduction on letter of credits, since they're not taking the oil just for the amount of the bonus. That's the reason for the reduction. 10 ACTING CHAIRPERSON RASMUSSEN: Thank you, 11 Moose. 12 Item 24 is approved as presented. 13 Item 25. 14 MR. HIGHT: Item 25, Chairman, is the authorization of the Commission to settle -- to purchase 15 a parcel of land in Malibu for \$90,000 and authorize the 16 17 lease of that parcel to the Department of Parks & 18 Recreation. 19 In this action, you will be acting both as Lands Commissioners and as trustees of the Land Bank 20 21 in the authorization to expend money. 22 ACTING CHAIRPERSON RASMUSSEN: All right. Are there any questions on Item 25? Is our name going to 23 be on the plaque, too?

MR. HIGHT: We will see that it is.

ACTING CHAIRPERSON RASMUSSEN: I come across these areas that I know that the State Lands Commission has had some dealings in, and the plaque always says, "Department of Fish & Game," and the "County of such-and-such," and the 'City of such-and-such," and never any mention of the fact that the real landowner is probably the State Lands Commission.

MR. HIGHT: Item 28 is the authorization to file a disclaimer on some parcels of land in Riverside County.

The area is not owned by the State and in order for the people there to get title insurance, the title company is requiring of them that they get something from us indicating we don't have an ownership. And we do not.

ACTING CHAIRPERSON RASMUSSEN: All right.

Any questions on 28? Item 28 is approved as presented. Item 29. 2 3 MR. TROUT: Item 29, as the Chairman will recall from her prior existence in the State Lands ₍,5 Commission, involves the grant to the County of Orange in 6 upper Newport Bay. It involves expenditure of trust money 7 for improvements in the redevelopment project around the Dunes. It's a million and a half. It provides for public access, ways that aren't there now. There will be a hotel and other improvements. And we recommend approval. 10 ACTING CHAIRPERSON ASMUSSEN: And because of 11 my past experience. I expect my name to be on this plaque. 12 (Laughter.) 13 MR. TROUT: Right.
