COMMISSIONER ORDWAY: Motion.

ACTING CHAIRPERSON RASMUSSEN: Seeing no hands, no item is removed; there's been a motion, the consent agenda is approved by consensus of the Commission

The first item on the regular agenda is Item 22.

EXECUTIVE OFFICER DEDRICK: Commissioners, this is an application by Chevron U.S.A. to self-insure all of their projects under State Lands; staff recommends approval.

ACTING CHAIRPERSON RASMUSSER: Any questions?

Item 22 is approved as presented by consensus.

I should note also that Item No. 27 has been taken off calendar.

Item 23, please.

EXECUTIVE OFFICER DEDRICK: Item 23 is the

Point Arguello Pipeline Company application for some

waste water outfall, seawater intake, and brine ditch charge line
at their proposed facility at Gaviota. Staff recommends
approval.

COMMISSIONER ORDWAY: Motion.

ACTING CHAIRPERSON RASMUSSEN: Any questions on 23? Item 23 is approved as presented.

Item 24?

EXECUTIVE OFFICER DEDRICK: Item 24 is a request

for an authorization to set aside and terminate a grazing lease at Goose Lake in Modoc County pursuant to a Superior Court order.

MR. SHERIDAN: May I speak about this?

ACTING CHAIRPERSON RASMUSSEN: Certainly. You certainly may. If anyone would like to speak, we ordinarily have a form that you can fill out with your name and address. But that's fine.

MR. SHERIDAN: I didn't know about that.

ACTING CHAIRPERSON RASMUSSEN: Just for future reference. We need your name.

MR. SHERIDAN: My name is Dennis Sheridan. I'm the person that had the lease on that Goose Lake property.

The Commission is reviewing a new application of mine, basically the same as the old lease. And I would like to seek permission to leave my cattle on the property until this can be resolved because of the transportation problem and finding new property to lease to run my cattle and things.

There's already cattle on the property in trespass. So, I would think that I would have as much right as anyone else as far as -- maybe even more right, because I have got an application. I have had a lease. And until it's resolved -- I don't know how long that would take -- but I don't have any --

COMMISSIONER ORDWAY: Are there any legal problems? Are there any legal considerations?

MR. HIGHT: Yes. I would like Joe Barbierl, who is with the Attorney General's Office and who's been handling this -- I believe the court order prevents us from --

COMMISSIONER ORDWAY: Allowing us to do that?

MR. HIGHT: Yes.

Is that correct, Joe?

MR. BARBIERI: Yes. That's correct. The effect of the order is that we set aside the lease that we've presently issued to Mr. Sheridan. And I think to allow him to do directly or to do informally what we can't allow him to do formally would be probably defeating the purpose and probably the letter of that order.

ACTING CHAIRPERSON RASMUSSEN: I think it would also be against our policy. I don't think we usually encourage what would in essence be a trespass on our land at this point. I think we're sympathetic to your problem. It sounds like there's not much we can do about that.

MR. SHERIDAN: What about other people that trespass on there? Can you make them remove their livestock also then?

COMMISSIONER ORDWAY: Mr. Hight?

MR. HIGHT: We can.

COMMISSIONER ORDWAY: I think that should be done then.

MR. SHERIDAN: There's a number of cattle on your property that I happen to have leased that are most definitely on your property fenced away from any private property. They are completely on State lands. If I have to remove mine, I would like to have those removed also.

EXECUTIVE OFFICER DEDRICK: Excuse me. I think what we probably ought to do, Commissioners, is to send a caple of people up there to meet with Dennis, Mr. Sheridan, and come back with a recommendation to me, and I can carry out your direction.

MR. KILEY: Sounds like a good idea. We'll go up and take a look at the actual situation and come back.

My information in the past has been that there was no fence in the outland away from the lake bed. And unfortunately, we don't have the staff to go up there and actually watch the cows and see where they go back and forth. If there is a fence that they could be kept behind, we certainly can look into that.

MR. SHERIDAN: Sir --

EXECUTIVE OFFICER DEDRICK: Well, at least see what the situation is.

MR. SHERIDAN: I happen to have some pictures of fencing and things like that. I've stated on numerous occasions that there is a fence separating a lot of your

land from the private upland already. I don't know.

Maybe I didn't state it to the right person. I don't know.

But I have got pictures of fence; got pictures of the

cattle. And I would be more than willing, if anybody wants

to come up there, I'll show them. I probably -- I don't

know i? I'm blowing my own horn or bragging or what, but

I probably know more about the State lands on Goose Lake

than the State Lands Commission does, because I've been

studying them for the last year and a half.

There's several things that I know hasn't been

brought to people's attention.

EXECUTIVE OFFICER DEDRICK: Mr. Sheridan, if you can stick around a little while after the meeting, you've come a long way, and the staff is here, I'm sure hey'd be happy to sit down with you to go over your pictures and maps and anything that you have.

Mr. Thompson, Moose Thompson, is here. This is the revenue projections from the Long Beach Unit for this year. If you would like Mr. Thompson to speak to that, I'm sure he would be happy to do so. There are several Long Beach items in a row, and you may want him to speak to several of those.

ACTING CHAIRPERSON RASMUSSEN: Yes. I think we'd appreciate hearing from Mr. Thompson.

MR. THOMPSON: The Calendar Item 28 is a reporting through March and not really very germane right now because of the things that happened in April. So, it's kind of a factual deal, and if you want to act on 28, there's really nothing to say about that, because -- COMMISSIONER ORDWAY: Motion.

ACTING CHAIRPERSON RASMUSSEN: Thank you. It's been moved. Any questions on 29? Or 28. 28 is approved as presented.

Item 29.

MR. THOMPSON: 29 is trying to get some things finished in this year's business without having to carry it over and modify the plan for next year. It's a small plan modification that change some plans on the type of pump they want to put in, and so we have to add it to the plan and transfer roughly over -- about a hundred thousand dollars between funds. We'd like your approval to get the project going.

COMMISSIONER ORDWAY: Motion.

ACTING CHAIRPERSON RASMUSSEN: Questions on 29?
29 is approved as presented.

MR. THOMPSON: Item 30, this is to follow up on the action that was recommended in which you adopted in April on accepting the plan and budget for the Long Beach Unit, and because of the timing, it was not very meaningful. But it was adopted, and we're bringing it back for some modification. This is the modifications agreed to between the staffs of the City of Long Beach and ourselves and the City Council of Long Beach has adopted this.

And basically, what it does, it reduces the plan and budget that had \$1.67 million down to \$147 million. This reflects the dramatic change in oil prices that went on. You can again see in the far right (indicating) of that exhibit, that shows on a dollar-per-barrel basis what's happened to oil prices. You can see the drastic change there. You can also see in black what the cost in the past has been at dollars per barrel and the four lines below are what our projected costs would be under this first modification of plan and budget.

The one on the -- (indicating) translates those into dollars per month. As part of this particular cost-cutting operation, this was covered in the modification of

the last one, we shut in high cut wells that would not py the cost of producing the wells. This resulted in an oil rate drop. But, as you can see, we're saving \$40 million in the next budget. Why, you translate that into oil, that's the equivalent of a \$10 barrel of oil, that's 4 million barrels of oil, and we're certainly not losing that much. So, this has been a question of following up on the drilling rig reduction that was in the seventh modification. We're down to two rigs for this year.

There are also reductions in the electrical power usage and every other way we can find cost reductions in the unit, so you can see the profit margin in the original area.

ACTING CHAIRPERSON RASMUSSEN: Thank you. Are there any questions?

COMMISSIONER ORDWAY: Motion.

ACTING Ci. IRPERSON RASMUSSEN: Item 30 has been moved and is approved as presented.

EXECUTIVE OFFICER DEDRICK: Moose, would you continue this? This is the subsidence item that I'm sure you'd like to speak to that for the record.

MR. THOMPSON: We settled out the subsidence costs with the City of Long Beach quite a few years back. The only thing that was left in that agreement was that we would approve their running their annual -- semi-annual, I'm

sorry -- benchmark surveys to see that there is no subsidence. And this is merely prior approval for them to incur those costs. COMMISSIONER ORDWAY: Long Beach is not moving, I assume? MR. THOMPSON: It is fluctuating up and down, as does all earth surfaces. And they go through this periodically, and then we report to you twice a year on the results of those surveys. COMMISSIONER ORDWAY: Metion. 10 ACTING CHAIRPERSON RASMUSSEN: 11 Item 31 has been Are there any questions? 31 is approved as 12 13 presented. 14 \_ Item 32. 15 EXECUTIVE OFFICER DEDRICK: Item 32 is the 16

EXECUTIVE OFFICER DEDRICK: Item 33 -- there is no calendar item. And the reason 1 left it on the calendar was for purposes of discussion. This is the general question of royalty oil, crude oil sales that the State -- we've been very successful in making until the cil price problem arose.

I asked Moose to give you a rundown on what is going on in the oil business. I thought this would be an appropriate time to do that. And also, staff is not at this time recommending rayalty oil arude sales, and I felt it was important that you should know the reasons for our making a recommendation of that some. If you would I sten to Mr. Thompson again, I'd appropriate it.

MR. THOMPSON: I think we've reported back to you the problem we had with our sell-off contractors; many of them have turned the oil back to us. Most of them have agreed to either paying the bonus even though they're not taking the oil. One or two of the others were in default. The problem is that we have bonus bidding above posted prices. The spot market is lower than posted prices; therefore, the sell-off purchaser is at a disadvantage of having to pay posted price plus a bonus when the actual market for the oil is below posted price.

Our leases also vary in our ability to take this oil. They vary from demand to take and give back. So,

what we're doing is reviewing each sell-off contract as it comes up to a tell nation date to see if it has a long advance notice. We would like to get out and see if there is a situation where we can get a bonus bid. Our review of the situation right now is that we don't think so. Spot markets are still below. We actually are physically receiving less than posted prices on some leases.

Mexico is putting a lot of oil on the market at around eight to eight and a half dollars a barrel.

The futures market is all below \$13 for much higher crude. OPEC is meeting fight now. And if some great miracle nappens over there -- maybe the prices will change -- but the general consensus is they're going to stay pretty much where they are.

We would like to continue using our particular insight on the market to see if the spec prices come up.

If they do, we'll come back month by month and tak for your approval to allow the sales.

Right now, we're sorry, but we don't see that we can go out and get posted price plus minimum bid in any bidding situation. So we don't want to any people to bid on something in which we'll get negative bids. End you'll see in the next item that comes to that there's actually negative bidding going on, which we do not suggest you go for.

ACTING CHAIRPERSON RASMUSSEN: All right. Thank you. Any questions? 2 EXECUTIVE OFFICER DEDRECK: There's no action required. I just wanter you to be understanding what was going on. ACTING CHAIRPERSON RASMUSSEN: EXECUTIVE OFFICER DEDRICK: Item 34 is a crude oil sales contract to MacMillan Ring Free Oil Company in the Long Beach area. COMMISSIONER ORDWAY: Motion. 10 ACTING CHAIRPERSON RASMUSSEN: Itam 34 has been 11 Are there any questions? 12 Item 34 is approved as presented. Item 35. 13 EXECUTIVE OFFICER DEDRICK: Mr. Hight will do 14 the legal aspects. 15 MR. HIGHT: Item 35 is the authorization to --16 17 COMMISSIONER ORDWAY: Would you move closer to the mike? 18 MR.
