3	the regular calendar will be item C-15, M. and T. Staten
4	Ranch. Jane Sekelsky, who is Land Management Division Chief,
5	will present that item.
6	MS. SEKELSKY: This project is proposed on two
7	parcels of land in and along the Mokelumne River in Staten
8	Island in San Joaquin County.
9	The berms in these areas which have provided
10	valuable Shaded Riverine Aquatic habitat are eroding from wave
11	wash from the river. Erosion of the berms has resulted in the
12	loss of essential habitat and a threat to the stability of the
13	adjoining levies.
14	The applicant, with the support of the Department of
15	Fish and Game, proposes to construct dikes in the eroding
16	areas, dredge sand from the riverbed and place it on the
17	berms, and revegetate the berms in order to restore the berm
18	in its habitat, and to protect the Staten Island levies,
19	The proposed project is one application of the berm
20	restoration concept developed by Sacramento River Inter-Agency
21	Mitigation team of which we are a member.
22	The applicant disputes the State's ownerships in the
23	lands underlying the project, but has applied for a permit
24	without prejudice to their right to contest the State's title
25	at a later date.

3 The project would be exempt as an experimental 1 2 management project from CEQA. You will see Exhibit C to your calendar item has 3 three special conditions which would be inserted in the permit 4 itself, and we would like to add one more which I will read 5 6 into the record. 7 "The applicant will be responsible for implementation of the project 8 9 including construction of the dikes, 10 placement of dredge material, and plant 11 selection and installation as set forth in 12 Section 3 of Exhibit B to this item, pages 98.5 to 98.6, subject to the approval and 13 supervision of the Department of Fish and 14 Game." 15 16 We have representatives both of the applicant and of 17 the Department of Fish and Game, if you have any questions, here in the audience, 18 19 CHAIRMAN McCARTHY: Any questions of members of the 20 Commission at this point? 21 All right. Any further comments from any of your 22 staff, Mr. Warren? 23 EXECUTIVE OFFICER WARREN: No, Mr. Chairman. 24 CHAIRMAN McCARTHY: Does anyone in the audience wish 25 to testify on Item 15 now on the regular calendar? The

1 Commission is ready to act otherwise.

2 The conditions just submitted including the one read 3 into the record will be adopted as a part of our action here. 4 We're ready to vote on the entire item now. 5 COMMISSIONER BURTON: That's fine. 6 COMMISSIONER TUCKER: Uh-huh. 7 CHAIRMAN McCARTHY: Unanimously adopted. 8 EXECUTIVE OFFICER WARREN: The next regular calendar items 24 through 27 save 25 will be presented by Mr. Paul 9 Mount, Chief of the Mineral Resources Management Division. 10 11 MR. MOUNT: Good morning. Okay, Mr. Chairman, Item 12 24, approve a negotiated subsurface, and there will be no 13 surface use, State oil and gas lease, it's 95 acres under Sand Mount Slough in Contra Costa County, for purposes of 14 15 developing the gas resource. 16 CHAIRMAN McCARTHY: Any questions by members of the Commission? Members of the audience? 17 18 Adopted as recommended. 19 Next item. 20 MR. MOUNT: Item 26, approve the assignments of 21 State oil and gas leases, PRC 410, PRC 429, and PRC 1466, and 22 right-of-way leases PRC 1961 and PRC 5968, in the Rincon Oil 23 Field, Ventura County. 24 In this assignment Arco will be released from all of 25 its obligations under the lease except for the obligation to

18	Department of Resources, and Governor's staff on the
19	implications of budget and personnel curtailments on the

22	the 27 percent budget cutbacks, that a restoration of 12 of
23	them would result in an increase in our projected revenues
.24	this year from \$10 to \$20 million at a cost of less than a
25	million to the general fund.

2	talk about the reality of what we can produce for the State in
3	revenue if we avoid a million dollars in cuts, or do you want
4	to save that for private discussior?
5	COMMISSIONER BURTON: I don't have sufficient
6	knowledge to do that today. I have asked your staff to work
7	together with the Lands Commission staff to look at the data
8	that was provided.
9	CHAIRMAN McCARTHY: I think the Governor's open if
10	we can make a good case. If we can prove that keeping staff
11	on hand that's going to cost us a million, staff plus
12	expenses, and they're going to bring in \$12 or \$13 million.
13	EXECUTIVE OFFICER WARREN: You said staff on hand,
14	all staff, all staff are gone. So it's not a question of
15	keeping them.
16	CHAIRMAN McCARTHY: These are cuts that have already
17	been made and therefore the revenue loss that we'll experience
18	because of it
19	EXECUTIVE OFFICER WARREN: We've identified certain
20	spots, 12 in 14 1/2 in number, could continue certain
21	projects that we had underway, which projects which have now
22	been suspended.
23	CHAIRMAN MCCARTHY: Okay.
24	EXECUTIVE OFFICER WARREN: And which would result in
25	what we believe to be revenue over the short term of an amount

3	we've identified those. We've given them to Finance.
4	COMMISSIONER BURTON: Happy to look at the data.
5	EXECUTIVE OFFICER WARREN: We await your call.
6	CHAIRMAN McCARTHY: Do you have any comments on this
7	part of it, Jim?
8	COMMISSIONER TUCKER: Huh-unh.
9	COMMISSIONER BURTON: I think you might have noticed
10	last year there was what we would consider to be a little
11	revenue producing agency, tax agencies, and they made some
12	similar arguments and the legislature added positions
13	sufficient to bring in additional audit money in those
14	agencies. And it's in that vein that we would look at this
15	data as well.
16	CHAIRMAN McCARTHY: I think we would really want
17	Finance to not wait for the legislature to take the action
18	assuming the case is persuadable.

20	would brief the Democratic and Republican members of the
21	Budget Committees along the same lines.

25	talk to Finance and anyone in the Governor's Office yet? I'd

10 1 like to take that step (irst and give them the opportunity to 2 have an opinion on this. EXECUTIVE OFFICER WARREN: Well Finance has been 3 4 fairly well briefed. The Governor's Office we've only met once with the Cabinet Secretary. 5 COMMISSIONER BURTON: Uh-huh. 6 EXECUTIVE OFFICER WARREN: What's his name? 7 8 COMMISSIONER BURTON: Loren Kaye. 9 EXECUTIVE OFFICER WARREN: That's right. 10 CHAIRMAN McCARTHY: Have you given all the information to Finance that could be given to them about the 11 12 revenue losses that you're estimating? 13 EXECUTIVE OFFICER WARREN: I thought so, but Mr. 14 Kaye's response to our meeting was that he would request Department of Finance analysts to meet with our staff. I 15 16 assume that would be for the purpose of going over the 17 particular activities and the number of PY's required to continue those activities. 18 19 I don't know when that will meet. I mean we're 20 ready to discuss, to discuss the situation in detail as soon 21 as our analysts or whomever is assigned to the task contacts 22 us. 23 COMMISSIONER BURTON: I don't have any problem if 24 you want to go ahead, unless the Chair does, go ahead and talk 25 to legislative staff or members. Obviously the budget's done,

11 we're past the point of incl ing something in tomorrow's 1 2 budget. 3 CHAIRMAN McCARTHY: But I would like to see Finance or someone in the Governor's Office in some way communicate to 4 5 the Senate and the Assembly budget committees that this makes some sense. That you've come to that conclusion. It makes 6 7 some sense. 8 COMMISSIONER BURTON: Yeah, if we reach that 9 conclusion we would. CHAIRMAN McCARTHY: If you don't, okay. I see a 10 chemistry developing in the budget this year that it's just 11 going to be very, very -- it's just going to be very tough. 12 13 And people are going to pick and choose what they're going to add on. And it's going to be just horrible. 14 EXECUTIVE OFFICER WARREN: I would feel more 15 16 comfortable ---17 CHAIRMAN McCARTHY: So I think if we can sort of, if 18 we can move Finance and the legislators to the line at the 19 same time so that neither counts it in their column, as to what they're adding or trading or whatever, that would be the 20 21 ideal way. EXECUTIVE OFFICER WARREN: One other thing, if I 22 23 may? If I can, I think, I appreciate your words and I think, 24 and I would feel more comfortable working with the 25 administration before meeting with the legislators because I

think your point that it's going to be, you know, going to be 1 2 accused of going around bypassing resources and the Department 3 of Finance and such is not the case, and certainly not the intention. 4 So if at all possible we can work this out. And 5 again we have no hidden agenda here. We want to be as 6 7 straightforward as possible. COMMISSIONER BURTON: So just let me know if you're 8 9 missing a deadline or something. EXECUTIVE OFFICER WARREN: That would be much 10 appreciated. 11 12 COMMISSIONER BURTON: Okav. EXECUTIVE OFFICER WARREN: There's one other thing I 13 thought I'd bring to your attention. I sent to you a week or 14 so ago, and I don't know if you received it, a report prepared 15 by the Marine Facilities Inspection Unit and Mineral Resources 16 Management in response to 2040. 17 18 It's a report that the legislature directed the 19 Resources Agency give it on implementation of 2040. If you recall that I think that inasmuch as I know that all of you 20 are very much interested in the implementation of oil spill 21 prevention response, I think you'll find that report very 22 23 reassuring. We're quite pleased with it. And we are waiting Resource Agency response in terms of how it's provided to the 24 25 legislature.

We met also with the representatives of our counterpart agency from Texas and we're going to, we're suggesting that an association of oil spill prevention states be formed nationwide hosted by Florida, Texas, and California, to further oil spill prevention as distinguished from recovery.

7 And the prospect for such an organization being 8 formed are good. And I think this will help us as we attempt 9 to move forward in the best available management practices and 10 best available technology in oil spill prevention.

I'd also like to comment that the other, a spill
recently reported in the front pages of the San Francisco
Chronicle as having occurred in the San Francisco Bay was as a
result of a transfer of oil from a barge to a tanker, and that
event is beyond our control. In fact, we have been
specifically directed not to become involved in such
transfers.

18 We also believe if an inspector had been present,19 that spill probably would not have occurred.

20 CHAIRMAN McCARTHY: Specifically directed by the 21 language?

EXECUTIVE OFFICER WARREN: I'm scrry?
