NOTICE OF INTENT TO CONSIDER AN ADDENDUM TO AN ENVIRONMENTAL IMPACT REPORT

An Addendum to an Environmental Impact Report (EIR) has been prepared by the California State Lands Commission (CSLC or Commission), as a responsible agency under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.), in response to an application submitted by the City of Los Angeles Department of Water and Power (City) to implement modifications to the Owens Lake Dust Mitigation Program Phase 9/10 Project. Proposed changes to the Project described in this Addendum include constructing berms and installing irrigation pipeline necessary for the implementation of dynamic water management (DWM) in two Dust Control Areas (DCAs) T13-1 Addition and T17-2.

On June 2, 2015, the City, as lead agency under CEQA, certified an EIR for the Owens Lake Dust Mitigation Program — Phase 9/10 Project (State Clearinghouse No. 2014071057).
