CONTINUATION OF RENT

LESSEE:

Santa Fe Pacific Partners, L.P. (SFPP)
Operating Partners to Kinder Morgan Energy Partners, L.P.

AREA, LAND TYPE, AND LOCATION:

Various rivers, sloughs and creeks, as well as San Francisco Bay and the Carquinez Strait, Contra Costa and Solano Counties.

AUTHORIZED USE:

Use and maintenance of a 20-inch-diameter petroleum products pipeline extending from the existing SFPP Concord Station in Contra Costa County to the existing SFPP Sacramento station in West Sacramento, Yolo County and continued use and maintenance of an existing 14-inch-diameter refined petroleum products pipeline known as Line Section 25.

LEASE TERM:

25 years, beginning October 20, 2003.

CONSIDERATION:

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff reviewed the rent under this lease and recommends that rent be continued at \$27,935 per year, effective October 20, 2019.

OTHER PERTINENT INFORMATION:

- 1. Approval or denial of the continuation of rent is a discretionary action by the Commission. Each time the Commission approves or rejects a continuation of rent, it exercises legislatively delegated authority and responsibility as trustee of the State's Public Trust lands as authorized by law. Upon expiration or prior termination of the lease, the lessee also has no right to a new lease or to renewal of any previous lease.
- 2. On November 13, 2003, the Commission authorized a General Lease Right-of-Way Use to Santa Fe Pacific Partners, L.P. (SFPP), Operating Partners to Kinder Morgan Energy Partners, L.P. for a term of 25 years

beginning on October 20, 2003 (Item 1, November 13, 2003). The lease will expire on October 19, 2028.

- 3. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
- 4. Approving the continuation of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.


A. Site and Location Map
